Q&A WEEK ONE

The answers to the Week One questions are below. Changes are noted with red text.

Q1: On p. 28, line 19, Zapata says that Ex. 5 indicates that the Cynical Songwriter account was created at 4:32 but that information is NOT on Ex. 5. Also, stipulation #1 states that the Cynical Songwriter account was created at 4:27. The stipulations say that the FaceBook account in question was created at 4:27 pm, but in the witness statement of Frankie Zapata, it says that he/she determined that it was created at 4:32 pm. How should these inconsistencies be reconciled?

A1: Page 8, Stipulation 1 should read: The "Cynical Songwriter" Facebook account was created on October 26, 2019 at **4:32 p.m.** from the IP address 172.16.254.1, which, on that date and time, was assigned to the Digby Theater.**

Four lines were omitted from Exhibit 5. The amended Exhibit 5 is attached here.

Q2: On p. 16, lines 8-19, Hubbard describes Miles and Hubbard signing the contract in Ex. 1, and then only needing to come up with a name, but the name is on the contract.

A2: Often witness statements do not match exhibits exactly.

Q3: Ex. 4 column 2 says that Miles' phone "last connected" to the Digby wifi Oct. 26, 2019 at 16:08. Can we get clarification of the meaning of "last connected"? Is that the start of a connection (meaning it connected at 4:08 and stayed connected for some indeterminate amount of time—connected as a verb), or the end of a connection (meaning that 4:08 was the last moment it was connected, having been connected for some indeterminate amount of time before—connected as an adjective)?

A3: "Last connected" indicates when the network was last accessed. The end time of the connection is not noted in Exhibit 4.

Q4: Can you offer any clarification of the timeline for Cy's sentence for burning down the school building?

A4: Cy was 18 at the time that he burned down the school. His sentence was probation and community service. He was not sentenced to confinement.

Q5: Marlo on p.15 line 4 says Marlo is "the lead vocalist and lead guitarist", but on p.16, lines 5-6 Marlo says Cy plays lead guitar and is the primary singer. Can this be reconciled?

A5: Marlo is speaking about the current status of the band on p. 15 (after Cy's ouster) and about the past status of the band on p. 16.
